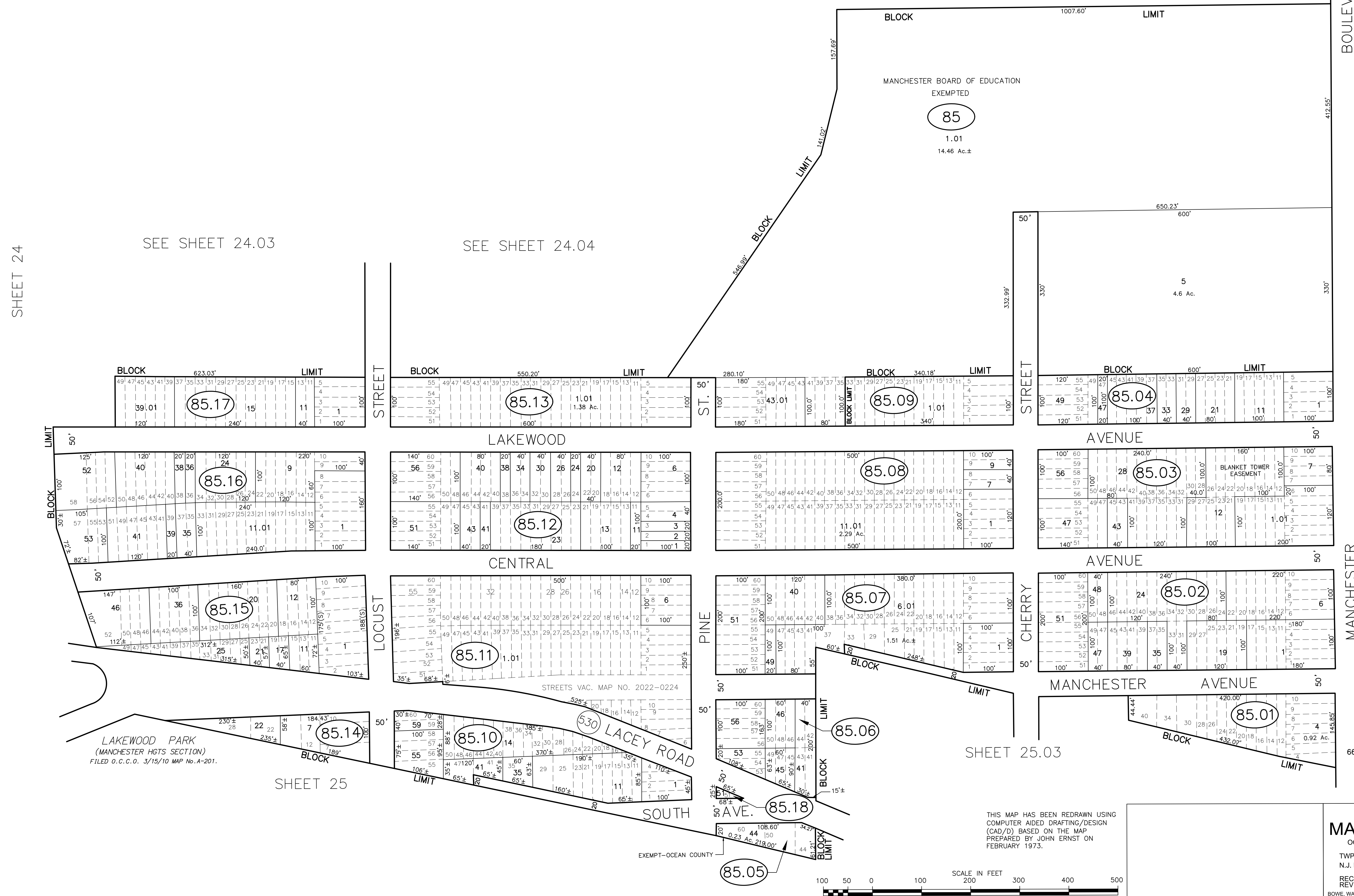

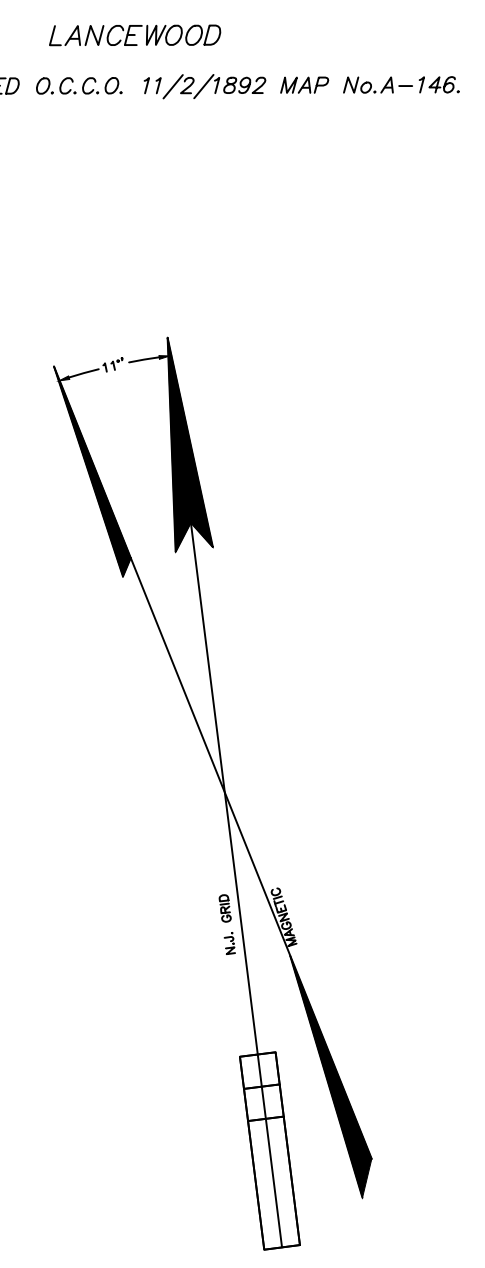

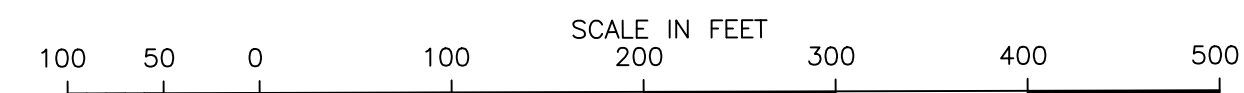


LAKEWOOD PARK
