# Manchester Township Council Meeting Minutes February 14, 2011

The meeting of the Manchester Township Council was called to order at 6:00 p.m. by Council Vice President Warren Reiter. The following statement was read by the Clerk:

"Adequate notice of this meeting was provided in accordance with the Open Public Meetings Act, pursuant to P.L. 1975, Chapter 231. Said notice was advertised in the Asbury Park Press, Star Ledger and was posted in the lobby of the Municipal Building."

This was followed by the salute to the flag and the following roll call:

# **WORKSHOP**

**Change municipal elections from May to November** – Mr. Trutkoff said due to health problems in his family he needs more time for analysis. Mr. Weiner said this would be a big savings for the Township. He has done some research. Mr. Weiner does not feel that it would mean a partisan election. The ballot would have to be clearly separated and marked "Non-Partisan Municipal Election" on the General Election ballot. He has a call into the County Clerk to ask him some further questions. If Council decides to move forward, the election date could not be moved back for ten years. Mr. Weiner felt that Council should not rush their decision. He suggested having some public comment and putting it on the ballot. Mr. Vanderziel is disturbed by the situation. Manchester took a non-partisan stance to avoid political party implication. Ten years ago the same question was on the ballot and residents voted against it two to one. Mr. Vanderziel felt the Council needed to examine this issue carefully. Mr. Reiter wanted more time to review it. He felt the most negative reason would be that the ballot would be too cluttered and municipal candidates and issues would be secondary to the partisan candidates and issues on the ballot. He wanted to get Mr. Wallis' comments on the subject. It was decided that this will be put on a future workshop.

Edward Lynch – Bridal Way: Mr. Lynch shared that three members of the Manchester First Aid Squad saved the life of a heart attack victim.

Fred Lund – LVW: Mr. Lund questioned the recreation fees and asked if the cost of the programs would be recouped. Ms. Zsoldos said some would be recouped, but not all. Mr. Lund felt that if the programs could not pay for themselves, they should be cut out of the budget.

Elio Mancini – Carrol Ct.: Mr. Mancini has been a resident of Manchester for over 25 years. He has attended as many Council meetings as he could. He was present when Mr. Work gave his reasons for changing the elections. Changing the dates would mean political parties would get involved.
