OATH OF OFFICE

Joan Brush was sworn in as Councilwoman by the Municipal Clerk to fill the vacancy left by Councilman Brendan Weiner. Mrs. Brush took the oath with her husband holding the family bible and her children and grandchildren looking on. Mrs. Brush then joined Council on the dais.

REPORTS

Mrs. Brush: Mrs. Brush attended the Penguin Plunge at Harry Wright Lake to raise money for the prom at Regional Day School. It is a worthwhile cause.

Mr. Frattini: Mr. Frattini mentioned that he recently received a productivity report from the Police Department. He thanked them for the outstanding job they do.

Mr. Vaccaro: Mr. Vaccaro attended various meetings and events throughout the Township including interviews to fill the vacant Council seat and the Manchester Coordinating Council.

Mr. Fusaro: Mr. Fusaro mentioned that meetings will be held throughout the Township in the next coming weeks to discuss the energy aggregation process. There will be public sessions at the Whiting Firehouse and Manchester Township High School. Council has also offered to go to all of the senior villages to discuss energy aggregation. Mr. Fusaro mentioned the process that Mrs. Brush had to go through to be chosen to fill the vacant Council seat. Mrs. Brush has been a resident of Manchester for over forty years and had volunteered many hours to Township events. Mrs. Brush founded the Municipal Alliance and was a lake supervisor for many years. She will be a wonderful asset to the Council.

Ms. Koutsouris: None

Ms. Skibo: Ms. Skibo welcomed Mrs. Brush to Council and told her the Clerk's office is always available if she needs anything.

Ms. Pellicano: Ms. Pellicano welcomed Mrs. Brush to Council.

Mayor Palmer: Mayor Palmer welcomed Mrs. Brush to Council and said she will be a tremendous asset. The Township recently purchased tasers for the Police Department which were utilized and the Mayor felt it saved the life of the person who was actually tased. Lastly, the Affordable Housing hearing was held last Friday and the plan was not approved. The basis for the objection of the Township's plan was that the MDG site was not developable. The Mayor said that was not the case. The next hearing will be in two weeks.

Ms. Lapp: Ms. Lapp congratulated Art Abline for receiving the Thomas Renkin award given through the Ocean County Joint Insurance Fund for his dedication to safety. Due to Mr. Abline's efforts, the Township received \$1,000.00 to use toward safety initiatives.

Mr. Gant: Mr. Gant congratulated Mrs. Brush on her appointment to Council.

PUBLIC:

<u>Dave Applegate – Northern Ocean Habitat for Humanity:</u> Mr. Applegate thanked Council for approving a Developer's Agreement to build an Affordable Housing unit in the Township.

Bridget Semanski – Country Walk: – Ms. Semanski spoke on behalf of her mother Carmen Semanski who is blind and uses a seeing eye dog named Yodel. Ms. Semanski lives in Country Walk. She has walked Yodel for years in the common space and has always picked up Yodel's waste. However, Ms. Semanski was given a complaint from the Board for not picking up after Yodel. The association has placed a sign up advising "No Dogs Allowed" in the common area where she has always walked Yodel. The same sign was not placed on any other common area throughout the village. Ms. Semanski asked Council for their help to have the association remove the sign and allow her mom to walk Yodel in the common area. Mr. Frattini asked Ms. Koutsouris asked if this should be brought to the attention of the ADA. Ms. Koutsouris advised that any ADA rule would supersede any Township or homeowner association ordinance. She said she would look into the ADA law and reach out to the attorney who represents Country Walk.

<u>Edward Lynch – Country Walk</u>: Mr. Lynch said speaking as a resident of Country Walk, he has seen Mrs. Semanski walk Yodel and she always picks up the dog's waste.

<u>Hank Glen – 29 Wyecliffe Rd.:</u> Mr. Glen asked what goals Mrs. Brush had for the Township. Mrs. Brush said she would like to have more rateables in the Township and hoped to see Pine Lake be used for swimming again.
