Mrs. Giercyk: Mrs. Giercyk stated the Census will be collected until October 31, 2020. Manchester's response rate is 78.4%, Ocean County 66.3%, and New Jersey is 69.2%.

Hank Glen, 29 Wycliffe: Mr. Glen asked if the Township was putting aside any money for a new municipal building. He inquired about a Maser bill on the bill list.

Mayor Palmer stated that the Township is purchasing property, but we are not going to build a new building. We would make improvements to this building and we may relocated police personnel.

Mr. Dasti stated that the Maser bill was from the solar project escrow regarding their work on the landfill solar project.
