REPORTS:

Ms. Zolezi: Ms. Zolezi stated she is honored and humbled to be here and to have her family here tonight at the meeting. She stated that there have been many changes recently but they are for the positive.

Mr. Vaccaro: Mr. Vaccaro congratulated Ms. Zolezi and her family. He attended various meetings including Special Energy Aggregation, Planning Board, and attended the most recent concert. The next concert will be on July 28 at Harry Wright Lake. Mr. Vaccaro stated that he reviewed the bills for this meeting. He stated that he continues to work with the Master Plan Committee for use of energy efficient methods such as solar use, geothermal, electric cars, and charging stations. He thanked everyone for the opportunity to speak.

Mr. Fusaro: Mr. Fusaro stated that he is the Chair of the Master Plan committee every second Tuesday of the month and he lost Council members recently due to the changes in Council. He stated that he reviewed the User-friendly budget and he felt was much easier to understand than the full budget document. He thanked Diane Lapp for the work on those documents.

Mayor Hudak: Mayor Hudak congratulated Ms. Zolezi and new acting BA Brandon Umba.

Brandon Umba: Mr. Umba stated that he will be in the office at 8:30 a.m. tomorrow and he looks forward to working with the township.

Sabina Martin: Mrs. Martin congratulated Ms. Zolezi and stated that her office is always available for anything she needs.

Kelsey McGuckin-Anthony: Mrs. McGuckin-Anthony congratulated Ms. Zolezi.

PUBLIC

Larry Lee County Walk: Mr. Lee inquired about the construction on a lot on Schoolhouse Road. He inquired about the status of the Cell tower on Route 530. Mr. Lee stated that recently JCP&L had a black out lasting over 30 minutes. He stated they are not receiving any nixles regarding any issues.

Bob Mullin stated that the development on that property is the Dollar General Store. When the new store opens, the old Dollar General will close.

Sabina Martin stated that the cell tower is complete. She contacted the company that built the tower and Verizon is making monthly payments to them but has not installed their antenna on the tower. Verizon stated that our location is on the schedule for installation hopefully by the end of this year.

Chief Dolan stated that JCP&L contacts customers directly when there are scheduled black outs. The Police Department does not receive advance notice, but he states the residents do receive a phone call ahead of time.

Judy Noonan, 25 A Stoneybrook: Mrs. Noonan inquired about the developer for the property on Route 37. She asked the status of the Heritage Minerals site and if the Township was approached about the new road from Mule Road through Berkeley. Mrs. Noonan stated that the buses for the seniors are leaving the area to spend money and she wants the town to continue reaching out to businesses so the residents spend their money in our Township. She informed the public about a recent scam she encountered.

Mr. Fusaro stated that the developer is Harvey Karen and no formal plans have been submitted regarding Heritage Minerals.

Ms. Zolezi stated that there have been meetings going back three years regarding the project on Route 37.

Al Yodakis stated that Hovnanian is still seeking State approvals for the Heritage Minerals site.

Mayor Hudak stated that he did reach out to ALDI before the pandemic, but he will reach out to them again.

No further public comment.
