REPORTS

Mr. Vaccaro: Mr. Vaccaro wished everyone a happy Valentine's Day. He attended various meetings. Mr. Vaccaro encouraged the public to contact the Senior Services department for information on their services. He inquired with the business administrator regarding the status of a dog park in the proposed Ocean County Park in Manchester. Mr. Vaccaro discussed electronic vehicle charging stations and ask for the Township's status with implementing them. He reminded the public to continue protecting themselves from COVID.

Ms. Zolezi: Ms. Zolezi attended various meetings including Planning Board, Economic Advisory committee, and the recent swearing in of new police officers and fire department personnel. She thanked the first responders and mentioned that February is Black History month. Ms. Zolezi reminded the residents to shop local, and to support our neighbors. She commended our municipal employees who go above and beyond for our residents.

Mr. Fusaro: No report.

Mrs. Brush: Mrs. Brush attended the police award ceremony and stated that the Police Department go above and beyond for our residents. She stated that Manchester Day will be back for this year; June 25th at Harry Wright Lake.

Mrs. Martin: No report.

Chief Dolan: Thanked the Councilmembers for their comments regarding the officers, and he appreciates the recognition. He talked about the new officers for fire department personnel, and the officer that recently retired.

Brandon Umba: Mr. Umba stated that it does not appear that a dog park was a part of the original plan for the County Park, but they have submitted a request to include it. He stated that an electronic vehicle ordinance has not been introduced because we are still waiting for Pinelands approval. Mr. Umba gave an update on the Homeland Tower in Whiting; Verizon installed equipment at the end of January and we are still waiting for a go live date. Still waiting for AT&T.

Mr. Vaccaro asked also for a bird sanctuary to be included in the County Park as well.

Brandon Umba stated that raised platforms usually needed for that; the County is in the early stages in developing the new county parks.

PUBLIC:

Judy Noonan 25A Stoneybrook Road, Whiting: Ms. Noonan thanked Mr. Umba for supporting recent bills. She inquired about several items including the original zone designation for Surf and Stream, information about 5G, and if Township ordinances apply to homeowner associations. She stated that the owner of the Barn establishment on Route 70 does a lot of work with the seniors and hopes the Township can work with her. She attended a recent Association meeting and the residents want to get more competition between Comcast and Verizon. Ms. Noonan stated that she does not agree with the electric cars and the charging stations.

Mr. Fusaro stated that Surf and Stream was designated as RA zone.

Brandon Umba commented on the situation with the Barn status and stated that there are laws to follow and the request should be coming from the property owner. He asked Ms. Noonan to reach out to him regarding the homeowner association issue. He also stated that the 5G ordinance is for establishing regulations and that Comcast renewal is up for a portion of the town.

No further public comment.
