Ms. Zolezi: Ms. Zolezi thanked Brandon, Diane, and all department heads for their work on the budget. Congratulated Municipal Clerk Sabina Martin for her hard work, and stated that she goes above and beyond. Ms. Zolezi stated that she is pleased about the pickleball stripping at the Holly Oaks Park.

Mrs. Brush: Mrs. Brush stated she is looking forward to the pickleball court. She congratulated Sabina Martin and thanked her.

Mayor Hudak: Mayor Hudak stated that the Green Fair will be held on May 18th from 2 -7 p.m.

Chief Dolan: Chief Dolan mentioned the Coffee with a Cop event had great success, and another event will be coming up in the future. He was present for an Eagle Scout presentation from Councilwoman Brush. Chief Dolan stated that the medication drop off event was a success, and he reminded the public that there is a drop off box at Town Hall for unused medication.

Sabina Martin: Mrs. Martin reminded everyone about the rabies clinic on May 21st. Dog renewals start on June 1st after we close out for the month and she encouraged everyone to use the portal. She stated that we are starting the process for sale of liquor licenses. She thanked Mayor and Council for the Proclamation, and she thanked her staff for their work in their office.

Judy Noonan, 25A Stoneybrook: Mrs. Noonan recognized the Municipal Clerk and her staff for all their work, especially during the elections. She appreciates all their work on the budget. She asked about the Comcast contract and if schools could share one of the two channels with the township.

Mrs. Noonan commented on Senate Bill #1697, critical race theory being taught in school, if marijuana can be sold in the Township, and commented on the electric vehicle ordinance
