Ed Lynch – Mr. Lynch inquired about the street location or address.

Township Attorney, Lauren Staiger responded that since they are vacant lots, there are no addresses, but they are between 6th and 7th Street.

Councilwoman Conniff asked if any member of Council had any comments on this ordinance. Seeing no comments from Council, Councilwoman Conniff asked if there were any comments from the public. Seeing no comments from public.

Hank Glen, Wycliff Drive – Mr. Glen inquired if the lot has any drainage issues, and the reason for the land swap.

Township Attorney, Lauren Staiger explained that there are no drainage issues, but the Township wants to keep the lot for future drainage or a basin. She explained it was reviewed and determined to be in the best interest to be put back on tax rolls.

Hank Glen, Wycliff Drive – Mr. Glen stated that he thought it was determined not to overbuilt in Pine Lake Park and asked what the advantage is.

Mr. Block explained that it's a good faith effort. Mayor Arace explained that the land swap would leave a 75' x 100' to be built on instead of a 50' lot to be built on. He feels that a land swap would leave the Township in a better position and not building on 50' lots.

Mr. Block explained that it is a temporary filtration system. \$150,000 for 6 months. We will upgrade to a filtration system. But designing, permitting, and building the new system will cost 1-2 million and will probably take one year to complete. Mr. Block commented that the water tower is for storage and the well needed treatment.

### **REPORTS:**

Mr. Hankins – On Beckerville Road, beekeepers are having a bear problem. If you see damage or issues with bears, please call it in. Also, there are new mulch restrictions with placement close to buildings.

Mr. Vaccaro – On May 15th he attended the police promotion ceremony. On May 16th with Councilwoman Conniff they attended the bi-weekly meeting. May 20th with Councilman Hankins we reviewed the bills. May 22nd with Councilwoman Conniff attended a new home dedication. Also, on May 22nd with Councilman Hankins attended MCC meeting at Crestwood Village #5. The owner of the Barn was the speaker. Again, he requested by June 12th meeting the status of the SAFER Grant and a 10-year energy plan. He suggested a feasibility study of solar panels on a carport over the parking lots. Lastly, the public has been advised that tolls will be increased on 1/1/2024, we should adopt a resolution to oppose the tolls.

Councilman Wallis – He asked the public to remember the Memorial Day celebration.

Councilwoman Conniff – She attended the Habitat for Humanity house dedication. A house from Lavallette that was donated and moved to Whiting on land that was also donated.

Announcements: Farmers Market is every Thursday. Memorial Day ceremony on May 29th at 10am at the Veterans WWII memorial. Our rabies clinic is June 3rd at the Ridgeway Firehouse from 8:30 – 11am and Township Garage from 1-3pm. She wished everyone a beautiful, happy, and safe Memorial Day weekend.

Mayor – No report.

Chief Dolan – Chief Dolan commented on the promotions and stated some officers were moved into the Detective Bureau. Thanked Council for resolution for new exams for police officers. He thanked Mayor Arace, Council and Diane Lapp.

### **PUBLIC COMMENT:**

Salvatore DelCollo – Silverwoods – Mr. DelCollo stated that he called Roxy and spoke to her and the Mayor's office. The Mayor was supposed to speak at our clubhouse. We need rent control for Silverwoods and all senior citizens. He asked if the lawyer was an advocate for the town and if she could send letters out. He liked what the Township did for the residents with trailers and he thanked everyone for listening to him.

Mayor to Mr. DelCollo – He will be there at the meetings, and he has heard from you and all the residents.

Township Attorney, Lauren Staiger suggested that there are departments within the County that could put you in contact with Senior Services and Consumer Affairs. They could get you in touch with people that could help you.

Greg Malko – Silverwoods – He stated that he felt what they did was extortion, and blackmail. Silverwoods, most folks are on fixed income, and he has been using his savings to get by. Think about what you would do if it was you or your family members. My neighbors are my family and I worry about them all. We need to do what's right.

Elizabeth – Silverwoods- She thanked the Manchester Senior Services Department for the transportation. They are very helpful and courteous. They are a vital service. She also thanked Teri, Municipal Clerk. I emailed her and immediately got a response. We are being bullied. She has done some research and found paperwork from code and standards regarding rules about raising rent which she gave to Council. Anything you can do to help us.

Township Attorney, Lauren Staiger commented that she and everyone here believes that it is appalling what is happening but please follow up with county services.

Mayor Arace stated that he will be bringing County Senior Services with him to the meetings at Silverwoods.

Salvatore DelCollo commented that he wants rent control for senior citizens.

Edward Lynch -3 types of people:

- 1) Make things happen
- 2) Watch thing happen
- 3) Wonder what happened

Councilwoman Conniff – Thanked residents for coming and bringing situations to light.

Michele Boyle – Huckleberry Lane – Mrs. Boyle asked when the ordinance regarding Schuls will be on the agenda.

Mayor Arace stated that it is on the Planning Board June 5th meeting agenda for review. Items needed to be looked at and cleaned up, language was updated. After the Planning Board, it comes back to council for second reading, public hearing, and comment.
