## **REPORTS:**

Councilman Hankins – No report.

Councilman Vaccaro – On July 12<sup>th</sup> attended the concert at Harry Wright Lake. The next concert is on July 26<sup>th</sup>. Attending various meetings including the Wildfire Safety Meeting, the bi-weekly meeting, and reviewed the bills with Mr. Hankins. Mr. Vaccaro stated that next month he will have a more comprehensive report on various areas of concern. He thanked Council for the time allotted to speak.

Councilman Wallis – Mr. Wallis said the concert was great, and he thanked Tracey Lynch, the recreation department, DPW and the police for their hard work. He attended a veteran's meeting where they discussed a PTSD program and other free services available to Veterans. We have a large community with veterans and all services are free of charge.

Councilwoman Zolezi – Ms. Zolezi commented on the great program for Veterans. The Manchester High School football players visited the Havens Assisted Living, which she thanked them for. She stated that at the July Board of Education meeting they recognized 27 AP students – congratulations to them.

Councilwoman Conniff – Mrs. Conniff stated that department heads working with recreation on Christmas in the Pines and Manchester Day.

Mayor Arace – He received a letter from a daughter whose mother is in the Havens. She said it was great that the football players came to the Havens and the residents couldn't stop talking about it. He was honored to celebrate with Jane Tringali who celebrated her 100<sup>th</sup> birthday. She is the great grandmother of Firefighter Coleman. As she was waiting for her great grandson to arrive, she was surprised when he arrived on a firetruck with firemen from Whiting Fire Department, where he is a member. He gave an update on the Verizon cell tower, which has been activated since May 2022. Verizon is actively looking for a third site for another cell tower.

Chief Dolan – Thanked Capt. Komsa for covering for me. On July  $22^{nd}$  we had the police entry exam. The written portion will be on August  $2^{nd}$  at 6:00 pm. National Night Out will be on August  $1^{st}$ . We will be joining Lakehurst at Lake Horicon from 6:00-9:00 pm. The youth academy will run from July  $31^{st}$  to August  $3^{rd}$ .

#### **PUBLIC COMMENT:**

Mr. Hank Glen – Wycliffe Drive – He questioned the \$5,600.00 Guardian Bill.

Chief responded that is the yearly subscription. He uses it for tracking officers (80) and EMS.

Pine Lake Park – What's the intention? Mayor responded that we would love to have it as a recreation area again, but we will get a cost analysis of the project. Looking at grants. We intend to investigate opportunities and look into cost and set up a plan.

Laura Flecker – Charles Avenue – What is in place to control out of towners at Scarco (Heritage Minerals) Lake? There are a lot of quads, bikes and out of towners coming into the property.

Chief stated that we are taking steps to fix that. We have been addressing and identifying access areas and closing them off. It is an ongoing process. If you see it or it continues, please call.
