REPORTS:

Councilman Vaccaro – On August 22nd Council President Conniff and he attended the bi-weekly meeting. On August 23rd Council President Conniff, Mr. Block, and he attended a Citizens Advisory meeting. On August 24th he attended the zoning meeting. On August 25th along with Mr. Hankins, reviewed the monthly bills. On Saturday, August 26th Council President Conniff, Mr. & Mrs. Wallis, Councilwoman Zolezi, Councilman Hankins, Mayor Arace, and he attended Manchester Day.

Covid is now spiking again with two new strains. With, he suggested to the public to protect yourself, family members and neighbors. If it continues to rise, he felt the Township should resume volunteer testing.

He suggested that the Council and administration oppose the NJ Bureau of Public Utilities and the new Senate bills. He further encouraged them to research to find federal funding with the kidney dialysis transportation program. It could be run out of Senior Services Department. Also, he recommended establishing a hospital and healthcare facility in Manchester. No one should have to travel for healthcare. It would also create new jobs. Atlantic Care in Manahawkin just opened a 40,000 sq. ft. center creating employment for 100 people. He wished everyone a great and healthy Labor Day.

Councilman Wallis – Mr. Wallis mentioned that the Veterans Committee flags of honor finally came in. They will be up for the various seasons and events. \$100.00 each and they are not making any money as the cost was \$96.00. They are 4x6 flags. Get one to support the veterans. Tracy and the recreation department worked very hard the last few weeks putting everything together, along with the Public Works Department and the Police Department. He mentioned that Congressman Smith was at Manchester Day.

Councilwoman Zolezi – Manchester Day was a great event. All the groups do a wonderful job, and we are proud of them. It was Tracy's birthday, and she changed her plans with the rescheduled date of Manchester Day. She was walking around near the Police tent and overheard a resident expressing to the police what a great job they do. She commended the Chief and the police department. She is grateful to the police and EMS. It is sad that summer is ending, but Happy Labor Day. Sports season is starting, congratulations to Manchester HS football team on their season opener win.

Council President Conniff – She would like to echo everyone's sentiments on Manchester Day. Great job by the recreation department. Per Mr. Vaccaro's report, she also attended the planned endorsement meeting last week, and we are planning a resolution for next month opposing the senate bills. We will be having community input meetings coming up in the fall, please come out.

Mayor Arace – As the council commented, Manchester Day was wonderful. There also was a car show in the Whiting Town Center. It was a great event for local businesses.

Chief Dolan – There are two Scott pack devices that are being donated to the fire department. They were bought with American Rescue Plan funds. Along with Bobby Baran's efforts and Council, we were able to obtain a \$34,000.00 grant. With the grant, the Township matches funds. We were able to purchase 8 new SCBA.

All fire companies have been very busy. Since the start of the pandemic, the Manchester fire companies have responded to over 2500 calls. The Mayor and Chief presented the Scott pack to the assist chief at Manchester Fire Company. September 7th, school is opening. We will be putting the signboards out.

PUBLIC COMMENT:

Judy Noonan – Stoneybrook Rd. – She stated that she is here as a resident. The Recreation Department does a great job but also thanked the EMT's. She went over a movie and a short story. She stated that she is at the end of the line with BPU, Governor Murphy, and Biden. It is time to stand up and push back. People need to start paying attention: electric bills, windmills, etc. When does it end?

Gail Abgar – Columbus Blvd. – Since speaking with the Mayor, the petition for the parkway got squashed, since it's going through. She wanted to make sure the police knew about the rumors going around that people are breaking into air conditioning lines to inhale the gas.

Joe Markowski – Eleanor Rd. – He stated that he is new to town and asked how long it takes for ordinance #23-30 to go into effect. When will the signs go up in Holly Oaks? Mayor said DPW will give him an approximate date for the signage. He will keep the residents informed. Lauren mentioned that the ordinance does not go into effect until 20 days after adoption.

Judy Kuhmichel – Winkle Court – At the new Dollar Tree, there is a chain link fence separating the property next door at the doctor's office. It is falling apart and is an eyesore. The Mayor stated that he will have someone go and look at it.

Mr. Vaccaro made a motion to close to the public portion of the meeting, seconded by Mr. Wallis. All in favor.

Mayor – A few more comments, at the Whiting EMS, we are rolling out community services. Judy will be working with the county, and they will have someone there three days a week helping with pension questions. Also, we have now preserved 35 acres of land at Cherry Street. There will be four single family homes being built to be donated to veterans.
