Mark Rohmeyer, of Morgan Engineering, gave a brief summary of the redevelopment plan. There are two adjacent properties that border Jackson that is 224 acres. It is located between S. Hope Chapel Road and Fremont Avenue that runs through the Renaissance community. The existing zoning is PED-2 and proposed to allow commercial. From 1970 to 1990 it was mining by Stavola Materials. In 2022 there was a study done and it was adopted by the Planning Board and the council. In 2023 the planning board reviewed plans and it is consistent with the master plan. Mr. Rohmeyer left a packet with the council for review.

REPORTS:

Councilman Hankins – Mr. Hankins thanked Councilman Vaccaro for getting us involved in the 25th Anniversary of the Renaissance event. He stated that when he was in Little League, Mr. Pruitt was a coach. He was also a paratrooper. Mr. Pruitt always said his jumps were at night because he always kept his eyes closed.

Councilman Vaccaro – On Saturday, September 30th Mayor Arace, Councilman Hankins, Council President Conniff, Councilwoman Zolezi, and himself attended the Renaissance 25th anniversary. Mr. Vaccaro thanked Councilman Hankins for getting us the firetruck to ride on. On October 2nd, he attended the Planning Board meeting. October 3rd Council President and he attended the bi-weekly meeting. October 7th Councilman Hankins and himself went over the bills. Mr. Vaccaro thanked the CMFO, Diane Lapp and the auditor for preparing for the comprehensive audit report and correction action plan. After many months of low Covid 19 cases, a new variant and subvariant cases have spiked. He reminded the public to take protection measures. Lastly, he encouraged the Council to put in place a healthy and safe protocol plan.

Council President Conniff – The Renaissance anniversary was very nice. She thanked Fire company 76 and EMS for the Touch a Truck Event. The Scalese family lost someone to neuroblastoma, and the event continues. She stated that she has a different aspect of Mr. Pruitt. Mrs. Conniff graduated with his granddaughter, Brittany. He raised his grandchildren and was always there for them and put the kids on the bus every day.

Mayor Arace – The Whiting Senior Services Annex is now open. We had a soft opening, and our official grand opening is on October 17th at 11:00 am.

Capt. Komsa – We now have an officer in every school. Our goal was to have this achieved and now with the resolution on tonight's agenda to hire a Class III officer, we have accomplished this goal. The funding is through the Board of Education.

PUBLIC COMMENT:

Gail Apgar – Columbus Blvd.- She has been attending zoning and planning board meetings and I am finding a lot of over building in the Pine Lake Park area. Also, draining issues with all the new building. I know someone who moved from the city and was excited to put in windows so she could look outside and then a house was built next door and totally blocked her view. They are approving houses to be built on undersized lots and asked what could be done to prevent this.

Mayor Arace – Undersized lots is a concern. We try to get them to get as close to conforming as possible. They buy adjourning lots to add to the undersize lot. The zoning board can look at the drainage issues with each application. We are looking at a plan and we are trying.

Gail – In my village, she wanted to let you know that Brian Rumpf will be speaking on October 17th at 7pm. 470 Rt. 530, Harmony Hall.

Alice DeVito – PLP – I agree with the overbuilding in PLB. When I lived in Staten Island, there was a fund. When you were building, you had to put money in the fund for open space.

Vanessa – Midway Avenue – In regard to my issue and the new ordinances, I emailed Amanda in code enforcement. Here is my email response from her. She handed out copies to Mayor and Council. Am I to understand nothing is going to get done? Many issues are still going on and me and my neighbors are still putting up with it.

Mayor Arace – We are working on ordinances. Some passed and we are still working on more.

Lauren Staiger – Yes, some aspects as far as overcrowding, we are still working on. But some issues can be looked at. Parking on lawns, unregistered cars, noise all can be addressed with code enforcement. I am meeting with them tomorrow, and I will follow up with them. Also, short term rentals and parking ordinances on books already.

Vanessa – I am very frustrated. I feel like I should just move. Owners of both of the rental properties do not care.

Joe Markowski – Renaissance – I am new in town and have a question regarding the ordinance procedure? Council President explained the procedure.

Joe Markowski– Can I see a plan for this redevelopment? The clerk stated she would email it to him. He also thanked Rob Sharry, the police and Council for keeping everyone safe for the Renaissance 25th anniversary event.
