Councilwoman Zolezi – Congratulations on Leisure Knolls 50th years, she was honored to attend. She has been in Manchester almost 50 years, and it was nice to walk the halls and see the history. Since the weather has been terrible, she encouraged the residents to be careful.

Council President Conniff – They are still actively working on the 4H program.

Capt. Komsa – He gave an update on the hiring process – 5 candidates. May hire two, as two officers are retiring, and they will be replacements.

School buses are stopping in local areas where no younger children should live.

Vanessa Cisneros Midway Avenue – Questions about zoning codes and parking cars on property. Lauren went over ordinance regulations but suggested contacting the Code Enforcement department with any questions and they can help her.

Councilman Hankins announced that the Fire Department just informed him that the traffic light at Route 37 and Colonial Drive is out. Any residents going that way, please be careful.
