CALL TO ORDER

The regular meeting of the Manchester Township Council was called to order at 6:00 p.m. by Roxy Conniff, Council President. The following statement was read by Teri Giercyk, Municipal Clerk:

The Municipal Clerk also noted for the record that also present were, Mayor Arace, Township Attorney Lauren Staiger, Business Administrator Carl Block, CMFO Diane Lapp, DPW Director Al Yodakis, and Chief Dolan.

APPROVAL OF MINUTES

The Regular Meeting Minutes from October 23, 2023, were approved upon a motion made by Councilman Vaccaro, seconded by Councilman Hankins and approved by the following roll call: Councilmembers Hankins, Vaccaro, Zolezi and Conniff; yea. Wallis absent.

PRESENTATION

Best Practices Presentation– 2023. Carl Block and Diane Lapp gave an overview of Best Practices. The questions change from year to year. NJ State Department of Community Affairs Department makes sure the government is doing the best they can financially. It is a point system for each yes answer. There were a lot of recycling questions. We did lose a point for not having a charging station. We have started water and sewer infrastructure, so next year if we are asked, we can say yes. OCJIF has mandatory training for personnel on the website. Scoring has a minimum of 29 to continue getting state aid, and we scored 38-1/2, so we are 100% eligible. Mr. Vaccaro asked if there were any cyber security questions. Diane responded that the state has formed a cyber security group and Manchester is part of that.

On 11/6 – he attended the bi-weekly meeting, which goes over the meeting agenda for tonight's meeting. On November 11th, myself, Mayor Arace, Councilwomen Conniff and Zolezi along with Congressman Smith attend the Veterans Memorial Day Service. It was the best one yet. Tracey Lynch and her staff along with IT, DPW workers did an excellent job. Geri Oliverie of Oliverie Funeral Home, read a beautiful poem. Councilwoman Zolezi – The Governors Excellent Award Veteran's advisory committee mentioned is a very prestigious award, and Manchester should be very proud and proud of our Veterans. Thank you, Councilman Hankins, for accepting the award. Tracey was a instrumental. Thank you, Veterans and PD, excellent job! Manchester should be very proud.

Council President Conniff –The Veteran's ceremony was very nice, come out next year if you missed it. Congratulations to Councilman Wallis on his election win. Reminder, Christmas in the Pines is on December 9th from 2-7 p.m.

Mayor Arace – Thank you to all Veterans for your service. Thank you to Tracey Lynch and staff for all their hard work.

Chief Dolan – As you can see, it is No Shave November. We have raised \$7500.00 for Sloan Kettering Memorial. We have had two officers go there who are now in rumination and one officer on his way. With Thanksgiving we have DWI patrol, please use Uber. Don't drink and drive. On Halloween patrols, the police department gave out \$500.00 worth of candy.

PUBLIC COMMENT:

Edward Lynch – Bridle Way – "Bravo Zulu". Which means job well done.

Donna McGlashan – Medford Rd.– Ms. McGlashan commented on several issues she has brought up in the past regarding landlord registration, outstanding bills for water/sewer/taxes, and EMS billing.

Carl Block clarified that the town does not sell your home, past due accounts get notices and could have a lien put on it. Also, the \$100.00 fee for landlords is to register rental properties. We are working on catching up on all rental payments.

Mayor updated on the new ordinance. Every landlord will register their rentals properties and pay the fee.

Lauren Staiger - There are a lot of miles in Manchester. If we are aware of rentals, we follow up.

Al Yodakis addressed the meter issue that Ms. McGlashan mentioned. We tested the water meter, and the resident didn't send in his car with the meter reading for quite some time. He agreed and paid the bill. He had used the water.

Gail Abgar – Columbus Blvd. – She thanked the Clerk, Teri. She asked her a question about what was being done across from Crestwood Village 5, and she researched and found out and got back to me.

John Mercer – Pine Ridge at Crestwood – Questioned Resolution 23-437 and Ordinance 23-38. He stated he is confused if the 2% is in place and why is it being discussed to change it to 3.5%? The Mayor updated on the confusion and why the change in the ordinance.

Lauren Staiger – We are in the middle of litigation. We can only say so much. We are working on a palatable agreement for all. The ordinance is not approved yet. It will be heard on November 27th. The ordinance is being challenged in Superior Court. The original ordinance is being appealed and we will have a second reading of this ordinance on November 27th. If adopted, we can sign off on settlement.

Mayor explained procedures with ordinance and court proceedings.

Mr. Mercer explained that 3.5% averages out to approximately \$25.00 per month. My lease if up at the end of the month. Come January – whatever cap is put on, 3.5% is maximum. So why do I have to pay the 6.2% increase I was given?

Frank Everly – Pine Ridge- If my rent increase is over 6%, am I still legally responsible? Carl responded that we cannot give legal advice. Mr. Everly – We are all senior on a fixed SS. These rent increases are not fair.

Ursula, a Pine Ridge resident – She stated that they feel sold out. We feel 3.5% is high.

Lauren Staiger - You have the opportunity to speak but you can't vote.

Mayor stated that he started this because he felt the concern from the residents. With legal fees and the outcome of the judge's decision, we are trying to come to an agreement. We don't want a worse outcome. We are trying to settle this.

Lauren – We can't discuss because we are in ligation. But we hear your concerns.

Owen, Boy Scout from 5th Avenue – Thank you to Public Works for paving the road. We ask if you could pave 5th Avenue.

Mayor asked Al – Where is 5th Avenue on the paving list? Al stated he did not know but will personally drive it tomorrow.

With no other public comments, a motion to close public portion and adjourn the meeting at 7:21 pm was made by Councilman Vaccaro, seconded by Councilman Hankins, and approved by the following roll call: Councilmembers Hankins, Vaccaro, Zolezi and Conniff; yea. Mr. Wallis absent.
