CALL TO ORDER

Chief Dolan responded there was a separate ordinance passed previously approving the four way stop signs. Yes, they are legal. Conversation between Mr. Glen and Chief Dolan regarding lights and stop signs, especially in private communities. Mr. Glen questioned if there was a four way stop sign at Wilbur and Holly Hill? Chief, said no, that must be a typo. Lauren stated with the amendment, you can still approve ordinance.

Mr. Hank Glenn – Wycliffe Drive – In regard to the reassessment, were we ordered by the County and when was the last one? Martin Lynch responded in 2020 the last reassessment, the County did order us, but before that happens again, now is the best time. There is a greater impact if we wait. Usually it is 1/3 up, 1/3 down and 1/3 stays the same. Mr. Lynch explained the process. This this preparing for the 2025 reassessment. Mr. Glen asked about the union resolutions and if all contracts were complete. Mr. Block responded that we had to make a side agreement with the union for the reassessment. Blue collar contract is complete, white collar is out of date but being worked on now and the police are not due yet.

Seeing no other comments from the public, Councilwoman Conniff closed this portion of the meeting.
