Ms. Zolezi: At the end of February, I attended the Manchester Township High School talent show. They have such talented students who performed honoring Black History Month. They did a nice job. Also, March is Women's History month. Thank you always to the police department, EMS and Fire who do an excellent job.

Mrs. Conniff: The Economic Development Committee will meet this month. With Saint Patrick's Day coming up, I want to acknowledge the anniversary of my mother coming to the United States 55 years ago. She came from Egypt for religious freedom. Please don't take it for granted.

Chief Dolan: On March 20th from 9:00 am to 11:00 am, we are having Coffee with a Cop at Starbuck's in Whiting. We are also having a retiree's lunch coming up and we are honored to have a retiree, Art Abline, who is here tonight, be joining us. Coming up on April 3rd, we are having Pizza with a Cop at Café Napoli.

PUBLIC:

Paula Fazio-Escudero - Thornbury Lane – LVW – In speaking of coming to the United States, Mother Cabrini was cantonized and was the Patriot of all immigrants.

Colin Lewis – Laurelwood Ave., Lakewood – I am with Love your Neighbor of Ocean County. I have been speaking with the Mayor, we went to the Grace and Peace church together, and I would like to meet with your senior community. Maybe having events like senior citizen proms, Wii bowling tournaments, or what you would like to see but move forward in getting this started. I also met with Diane, superintendent, regarding getting this together. Maybe the Council liaison for the seniors would like to meet and we can get together. Also, Ocean County does not have homeless shelters. They have group homes for both men and women. I have information on a new program to put a tiny home in certain towns. They are trying to select which towns would like to participate. He will send the information to Carl Block.

Council President Conniff – Councilman Vaccaro is the Council liaison for the seniors, and I am the school liaison, we will review the information.

Edward Lynch – Countrywalk – Just to let you know, corned beef and cabbage was started by people of Jewish decent, not originally Irish.

Carlos Almanzar - Annapolis Rd, South Toms River – I am not a resident of Manchester, but I graduated from Lakewood High School, and I am a businessman. Three and a half years ago, a got into the cannabis business. I am glad you waited for the first wave of cannabis to go by. I don't think a dispensary is the best choice here, but growing it is a good idea. I would like to bring this to Manchester Township. South Toms River is adding two more facilities and Lakehurst now has one. They will not be able to have enough product. I think a hydroponic facility would benefit you. It would employ around 200 workers, and seniors would love to work. Thank you.
