There are 10 developers interested in putting in bids, and a contract will be awarded on May 13th. The program is run through NJ BPU and solar panels can be within 15 miles of the Manchester borders. To opt in, they will be going by 80% of the LMI threshold which will be \$104,240.00 or below. In Manchester, 700 households can participate. There is no cost to participate. Launch program-1/1/2025.

On 3/20 I attended the general meeting at Renaissance and on April 17th the speaker will be Mayor Arace. 3/23 myself and Councilman Hankins reviewed the bills. 3/25 Councilman Hankins and I attended the Council coordinating meeting at Crestwood village 5. Senior Services started the Senior Social program for resident 60 and older. If anyone is interested, please call Melissa DePalma at senior services. Regarding the comment to the squatter issue in residences while homeowners are away for the winter month or out of town; this is a reminder to be good neighbors and vigilant community members. Mrs. Conniff: I would like to congratulate Mrs. Pedroza, Manchester's first women superintendent. Councilwoman Zolezi and I attended Challenge Day at the school. It is run by a great organization. Also, New Horizons in Autism will be coming to Manchester. Grand Opening will be on Wednesday.

Mayor Arace: none

Chief Dolan: We had Coffee with Cops at Starbucks, Jordan Weed did a great job. Pizza with Police will be on April 3rd at Café Napoli. Happy Easter.

PUBLIC:

Felicia Finn – Paterson Avenue – How will choosing to opt in be done for solar? Also, only 700 people? There are a lot more people who would need it.

Loren-Gabel – choosing will be done by Manchester and Gabel.

Felicia – I wish it could be more. I hope the 700 people are the ones in need first.

Councilwoman Zolezi – How was 700 people established?

Gabel – the unit determines maximum benefit. With 5 MW, it calculates to 700 homes.

Karen Perry – Thornbury Lane – First, nice picture of Councilman Wallis and Councilwoman Zolezi with the Easter bunny. To Councilman Vaccaro, you mentioned Senior Social event. I did not know anything about it. Judy Noonan answered that she sent a flyer to each of the villages. Karen Perry – what does it entail? Different events. Chair yoga, painting, bingo lunch, lunch with the mayor. It varies. They are also looking for suggestions for future events. Karen Perry – with the solar, only 700 people maximum. Take into consideration the number of people who could use the savings.

Councilman Vaccaro asked Gabel, with the \$104,000.00, is that gross? With pension, SS and stocks that go up and down, how do they calculate? Loren – Gabel – it is a honor system and you attest to the income.

Judy Noonan – Stonybrook – A lot of people will push back with the 700 number. I work with the high school with the computer program with the seniors. These students have a lot of patience. It is a great program. Thank you for the Anchor program resolution. I called and was advised that the state is sending out the checks in batches. I would like to address an issue, squatters. Squatters started in England and came to America. I'm concerned about squatters, and it is difficult to get squatters out of the house. We have been lucky to be in a cocoon here in Manchester without these issues, but it could still happen. To Council and Chief Dolan, please think about it and investigate.

Judy Kuhmichel – Country Walk – I am concerned with the 700 people maximum. Pinpoint the people who need it most.

Carl Block – With the BPU allowance, we can look at another program if this one is successful.

Tom Farrell – Hudson- I couldn't agree more with Mr. Block. Do we have an obligation to consume the 5 megawatts? Gabel – no, if not totally used, it goes back into the grid.

Gail Apgar – Columbus Blvd. – With the Anchor program, I always worry about state programs. The squatter thing. I am very worried about it. I believe if the squatter is there for more than 30 days, they become a tenant. Very hard to get them out.

Councilman Hankins – Judy, Manchester is a bubble not a cocoon. Our police work very hard and try to keep the problems in other towns, out of Manchester.

Councilwoman Zolezi – regarding the squatter issue, reminding us to be good neighbors. We should look out for each other.

With no further public comments, Council President Conniff asked for a motion to close public comment at 7:20 p.m. A motion was made by Councilman Vaccaro, seconded by Councilman Wallis. All yeas.
