Judy Kuhmichel – Countrywalk – She showed a picture to the Mayor and Council regarding a property in Whiting. She showed a picture of how bad it looks near the fence of the Dollar General. The Mayor took the picture and will forward it to code enforcement for follow up.

Tom Farrell – Hudson Pkwy. – This room we are in now is also the court room. The court now has Plumsted and on court day it is standing room only. I think it is a disgrace with people being subject to long lines. Also expensive, as a Police Sergeant stands in the back, an officer stands in the front and one or two more officers are in the room. The citizens shouldn't have to wait four or five hours.

Mayor – I haven't heard of any long lines, but now that you have brought it up, I will speak with the court administrator and see what can be done.

Carl – everyone waiting in line decided to make a plea and wait until that morning to do so. They have to wait in line and speak to the prosecutor.

Diane Lapp – courts are never at the same time. Lakehurst and Plumsted are at different times.
