REPORTS:

Mr. Hankins: I just wanted to let everyone know that the Battle of Monmouth, Revolutionary War reenactment is wonderful if you get the chance to go see it.

Mr. Vaccaro: Thank you, Council President, and welcome everyone. I want to wish all the fathers a Happy Father's Day and enjoy your special day. Again, I would like to remind everyone how lucky you are to live in Manchester Township, the Gemstone of the Jersey Shore. Employees, EMS, Fire, Police and everyone help maintain the status of the best place to live in Ocean County. On 6/3, I attended the Planning Board meeting. 6/4 Council President Conniff and I attended the bi-weekly meeting, which you know helps prepare for tonight's meeting. On Saturday, 6/8 Councilman Hankins and I reviewed the bills. I was asked by the senior advisory council to announce that the senior farmers market vouchers are now in effect as of today, June 10th. You must be 60 years or older, a resident, and not exceed financial guidelines. Vouchers for \$50.00 will be given out on a first come first service basis until the vouchers are gone. Lastly, I suggest and request that the senior social program in the Eastern section be restarted. Madam President, thank you and that concludes my report.

Mrs. Zolezi – I attended the PAL fishing derby. It was fabulous and well attended. I love the idea of making positive decisions. Reminder that Manchester Day is coming up at the end of June. Lastly, after seeing all the traffic and crashes lately, I want to remind everyone to take an extra minute or two, these accidents could be avoidable.

Mrs. Conniff: I agree Michele. Now that summer is here, be more mindful on the roads. Please leave enough time.

Chief Ellis: On Wednesday, Corporal Collins retired. On Thursday, Councilman Hankins and myself and other officers attended the 200-club awards ceremony.

Carl Block – I attended an open house at Country House Fire Station #3 for a PFOS presentation. I attended on behalf of the town. I will have Josh put on the website a link with maps and an overview. They identified 45 private wells in Manchester, which is not that many. They will have ongoing testing.

PUBLIC:

Mr. Hank Glen – Wycliff – (to Carl) I appreciate that, but there was an article in the press. A press release would be good.

Councilwoman Zolezi – This is not new. The base has been dealing with this issue for several years.

Karen Perry – Thornberry Lane – I too have a question. I have lived in Manchester since 1978. There has been no swimming in the Pine Lake Park lake because it is contaminated from the runoff of the base. It is coming to the surface, and I am concerned.

Councilwoman Zolezi – I did read that article as well. To clarify, the closure of Pine Lake is not directly related to PFOS.

Council President Conniff – There are numerous reasons the lake is not swimmable but not related to the base.

Carl –They are monitoring wells and 20 additional sites. Carl explained what PFOS stands for. Our well #4 is a seasonal well and PFOS was detected before we turned it on. We put a filter in place. PFOS can be treated if known about it.

Council President Conniff – I spoke to the Mayor. He confirmed he will have a press release coming out.

Councilman Vaccaro – Is the government paying for all this? Carl – the base is reimbursing us.

Vanessa Cisneros – Midway Ave. – I am in the same situation that I was in, but I want to thank Chief Ellis. We had more patrol, but on Saturday, I had to call again. The police were there in five minutes. Also, I came in late, can you tell me what ordinance #24-26 is about?

Carl – It is an amendment of an existing ordinance regarding storage containers and using them for other reasons.

Vanessa asked how many cars are allowed without license plates. There are three parked across the street, two in the driveway and one on the grass.

Gail Apgar – Columbus Blvd. – I am concerned about her safety. Is there a way you could patrol more.

Joe Markowski – Eleanor Rd. – Councilwoman – did you catch any fish?

Michele responded, No, I didn't.

Chief?

Chief Ellis responded, Yes, my son did.

Mr. Markowski, I have a question regarding the ordinance with containers in the street. How does that affect private communities? Especially with trailers for lawn companies in the street and containers for roof work?

Carl – They are not permanent containers and in private communities they have their own set of regulations.

Joe – Last question. I was looking at the township website and looked at the history. It was last updated in 2016. Maybe a historian can look at that and update it for you.
