MANCHESTER TOWNSHIP REGULAR MEETING MINUTES May 28, 2024

Carl Block – If you mean, dumping fees, they are regulated by the BPU. We are the host town and receive the host fee.

REPORTS:

Mr. Hankins: The Memorial Day service was well attended. Very nice.

I remind everyone that Manchester Township is the gemstone of the Jersey Shore. Thank you, Diane Lapp and staff and the auditors, for the budget, and I would like to compliment Mayor Arace, who did an excellent job with the presentation. On 5/15, I attended the Renaissance general Men's club meeting. Our speakers were Al Yodakis and Carl Block and the updates on the water system. On 5/25 Saturday evening, reviewed the bills with Councilman Hankins. 5/27 I, along with Mayor Arace, Council people Conniff, Hankins, Wallis and Zolezi attended the Memorial Day service. It was well attended. This years' service was the best prepared and presented. Thank you to Tracey Lynch and staff along with the IT department, DPW, PD, 1st responders, EMS and everyone who helped. I was in Washington, DC last week and was appointed to the USEPA Committee. Lastly, Memorial Day, Tracey does a great job, and our community does a great job participating. Thank you, veterans, for your service and since I wasn't at the last meeting, congratulations Chief Ellis.

Mrs. Conniff: Amazing Memorial Day, Tracey and staff. A lot of work goes into it. Tons of events for the summer. Diane, thank you again. Diane is very conservative when it comes to the budget.

Mayor Arace: Thank you, Diane, Carl and Council. We all work together well. Diane, you poured your heart into the budget. Also, thank you Tracey and her team.

Diane Lapp – Thank you Andy. I sent the budget to the state April 23^{rd} , and on Thursday the state had a recommendation. We were able to work on it with Andy's help and by 10:00 am this morning, the state said it was okay to proceed.

PUBLIC:

Ed Lynch – Bridle Way – Compliments to everyone, especially Councilman Wallis. He served in both the Marine Corp and the Airforce. He tells a quick funny story about the Airforce.

Vanessa Cisneros – Midway Ave. – with her neighbor Myra Frio who doesn't speak English, so she will be translating for her. She hands in pictures of the situations that she has been reporting since last year. The situation continues with all the drinking and hanging out for hours, late into the morning. They are loud and leave garbage all over the place. Someone called DCF for a child issue. There was a 2-year-old sleeping on the sidewalk while they were partying. She can hear them talking about drug deals. They call her names and point and say she is the one who calls the police and takes pictures of our license plates. She left NY and moved to Manchester to raise her son, and now she feels scared and doesn't want to live here anymore. She plays a recording from inside her house of how loud they were at 1:00 am.

She stated that Amanda told her that there were violations for garbage but there is still a rental issue. They move tenants in and out late at night and she is always seeing new people.

Mayor to Gary – with the rental issue – is there something that we can do better or follow up?

Gary – yes, we keep records of the tenants' names but as for the noise complaints, you can continue to call the police.

Mayor to Chief – when it comes in as a noise complaint, I know it's not a high priority, but we still go there and if there are repeat offenders, we can issue summons. Chief – yes.

Gary asks for the addresses of the two problem rental houses: 2675 and 2667 Midway Avenue

Gail Apgar – Columbus Blvd. – This lady touched on a subject. There are 475,000 illegal people in the state of New Jersey. Are they coming to Manchester? Also, the homeless.

Mayor – I haven't heard of any illegals. All rentals should be registered with the town. We have this implemented with steps in place.

Gary – Yes, we do require tenant's names on rentals.
