Councilman Hankins – I have been just notified by Bobby Baran that Manchester EMS has been nominated for an award and I will let everyone know when we here if we won.

Mrs. Conniff – The EMS is an amazing team, and very professional. The clerk's office has been very busy with elections and calls regarding voting. Early voting is from 10:00 am to 8:00 pm and Sunday from 10:00 am to 6:00 pm. Election days hours are 6:00 am to 8:00 pm.

Chief Ellis – I would also like to express congratulations to the Manchester Township football team. On 10/20 the Treat or Trunk event took place with over 900 participants. Lastly, Halloween is this week. We will additional patrol out to hand out candy and hand out tickets. Have a safe Halloween.

Judy Noonan – Stonybrook – Manchester has a new superintendent, and she is doing an excellent job. I know the school tax is the highest on your tax bill, but it is money well spent. I am very impressed with her. She is up to date on everything going on. I want to let everyone know there will be a Thanksgiving dinner free to anyone in need. Also, the Whiting Vet has closed. Anyone who needs records there, please call them by this week. Lastly, Channel 21 is up and running.

Gail Apgar – Columbus Blvd. – I attended the zoning board meeting. There was discussion when building these small houses and putting up fences. The neighbors were very upset at the situation and Mr. Jerman keeps building three bedrooms homes on undersized lots and with no garage the front of the house will be all parking and no lawn. Overbuilding.

Donna McGlashan – Medford Rd. – Chris Smith was here some time ago and said we should be getting money for our water system. Are we getting money? Our water is bad and looks yellow, can it be tested?

Carl – Chris Smith put in for funding. It went to senate and needs to be approved before it goes to the president. It times time. Are you in the western side? With public water, we are required to test the water, and the results are below the state requirements, but today we did have a break, so the water might be discolored.

Linda Chapman – 5th Ave. – who do I call regarding rental property maintenance? Code Enforcement. When the mayor gets elected at the county, who will be the next mayor?

Roxy explained the process of how council chooses an interim mayor in January and in November there will be a special election for mayor.

Chief – one more thing. Facebook live with Sgt. Fastige had a great presentation with parking advisory, legal vs illegal parking and title 39, especially parking in Pine Lake Park. If you see a problem, please call us.
