On 3/11 attended the Renaissance Men's Club meeting. On 3/18 attended the bi-weekly meeting. On Friday, 3/21 Councilwoman Drake and I reviewed the bills. Attended the Manchester Coordinating Council meeting today with Mayor Hankins. He thanked Chief Ellis and K9 Buck. I would like an update on the 10-year plan for energy conservation and a follow-up on the solar carports that could generate high mega hours. I urge everyone not to enroll with energy conservation companies until we advise you regarding our plan. I encourage residents to shop locally, it creates new jobs as we are the Gemstone of the Jersey Shore. Madam President this concludes my short report and God Bless America and all the residents of Manchester Township!

Ms. Zolezi – Thank you to the Police Department and all our emergency services, and thanks for sharing the swearing in of K9 Buck. She commended the Veterans and Veterans Advisory Committee. She reminded the public that the next Environmental Commission meeting is tomorrow night in the Court Room.

Ms. Conniff – Council President thanked the Chief for allowing the swearing in of K9 Buck and mentioned that it is amazing to see all the police officers in attendance for support.

Mayor Hankins – Mayor reported that his office received a complaint regarding the playground at Harry Wright Lake, and he has confirmed with DPW Director Al Yodakis that this site is on schedule for upgrades this year. Mentioned the recent fatality at the Heritage Minerals property. We are looking into increasing fines for trespassing and reminded the public that this is private property. Mayor mentioned that he will be joining the next Police Department Facebook live event this Thursday at 7 p.m.

Chief Ellis – Stated that the Police Department is continuing to with the property owners of Heritage Minerals. There will be joint training event with emergency services at that location. Discussed the Goal Zero enforcement detail in Ocean County. We are partnering with Monmouth County, which is a grant funded detail encouraging zero fatalities on local roadways. Enforcement will be on Rt. 70 threw Ocean County.

PUBLIC:

Karen Perry, Thornbury: Commented that there are a lot of kids misbehaving at the Township parks.

Chief Ellis responded that we will be hiring Class 1 officers, and their duties will include patrolling the local parks, lake, and parades. They will be working up to 30 hours each week.

Councilwoman Zolezi mentioned that social media is not the best avenue for communication. If you have any questions, concerns, or comments please reach out to the staff at Town Hall or the Police Department.

Councilwoman Drake supports Councilwoman's Zolezi comments and suggested that this be mentioned on the next Facebook live event.

<u>Gail Appar, Columbus Blvd.</u>: Thankful for the light at Manchester Blvd. and Rt. 70. Discussed an issue where a mailbox was damaged in her community; police were contacted and they were excellent. Discussed recent spam mailing.

<u>Judy Noonan, Stoneybrook:</u> She loves the picture of Councilwoman Drake and her K9. Discussed recent senior community issues. Someone may be coming to the next Council meeting to discuss.

<u>Alice DeVito, 4th Ave.:</u> Discussed recent Planning Board meeting, and an engineer's comments regarding our Master Plan and building height requirements.

Lauren Staiger responded that height requirements are in the Township Code.
