PRESENTATION

Swearing in Dawson Palmarini as an Honorary Firefighter, Honorary EMT and Honorary Police.

Bobby Baran read Dawson's bio. In 2019, Dawson was involved in a very serious motorcycle accident. He spent three months in the ICU/Trauma Unit and then Children's Specialized hospital for rehabilitation to relearn basic skills such as walking, speaking, and feeding himself. Dawson has come along and has chosen to dedicate part of his therapy to thanking not only the individuals who saved his life, but all the first responders. His goal is to visit every police, fire and EMS agency in NJ and has the goal of entering the Guiness Book of World Records on becoming an Honorary Police, firefighter and EMT with as many agencies he can. Dawson has even been featured on New Channel 12 with the segment titled “Man on a Mission”. Chief Ellis and Bobby Baran presented Dawson with shirts from police, fire and EMS.

Councilwoman Zolezi congratulated Dawson. We are so proud of you. Good luck getting in the Guiness Book of World Records.
