NOTICE OF SALE OF PROPERTY FOR NONPAYMENT OF TAX, ASSESSMENT, AND OTHER
MUNICIPAL LIENS

PUBLIC NOTICE IS HEREBY GIVEN THAT, I, ANDREA GASKILL, TAX COLLECTOR of the Taxing district of the Township of Manchester, County of Ocean, State of New Jersey, pursuant to the authority of the Statutes in such cases made and provided will hold an online Tax Title Lien Sale for non-payment of taxes, water, sewer, and other municipal charges on Tuesday October 6, 2026, at 8:30am at <https://manchester.newjerseytaxsale.com/?>. The said lands will be sold to make the amount of Municipal liens chargeable against the same on December 31, 2025, exclusive however of the lien for the year 2025 as computed in the following list, together with interest on said amount October 6, 2026, and the cost of sale.

Said lands will be sold in fee to such persons as will purchase the same, subject to redemption at the lowest rate of interest, but in no case in excess of 18 per centum per annum.

Any parcel or real property for which there shall be no other purchaser will be struck off to the Municipality in fee for redemption at 18 per cent and the Municipality shall have the same remedies and rights as other purchasers, including the right to bar or foreclose the rights of redemption. The right to redeem shall extend six months from the date of the sale or from the date of the service of the notice when the Municipality is the purchaser and extend for two years from the date of sale for all other purchasers. Payment for liens purchased shall be made via wire transfer prior to the conclusion of the sale, or the property shall be resold.

At any time before the sale the undersigned will receive payment of the amount due on any property with interest and cost incurred up to the time of payment. Only cash, certified bank check, or money order will be accepted in payment.

The said lands so subject to sale or described in accordance with the last tax duplicate, said lands to be sold are described as follows. In the event that the owner of the property is in active military service, the tax collector should be notified immediately.
